

Estrella War Article

Greetings all,

Amazing but it's already time for Estrella War XVIII posts! Pre-Registration is officially open as of 8/1/01.

We have changed the "wet" RV space policy. This year it will be in the form of a lottery. If you would like to be in the this lottery, send you name and contact information to me before 9/30/01 (postmark).

The drawing will take place in mid-October and payment (\$120) will be due by 10/31/01 postmark.

As with last year, we will accept personal checks during the early pre-registration time-period. So, if you pre-register by 10/31/01 (postmark) you can write a personal check and get the early discount (\$5 adults

and \$2 youth). (Note: please remember that personal check payments will have a 6-week delay for confirmation letters to be mailed.)

The fees are the same as last year: \$40 for members, \$45 for non-members and \$20 for youth (9-17 at War.)

As with previous years, pre-registration is meant to make Troll go faster and allows folks early entry to the site (8am on 2/13 vs. noon for everyone else). Troll will go faster, as your information will be ready already. You'll come to the door with your pre-registration confirmation, member ship verification, and mundane ID (like drivers license) to be allowed access to the pre-reg line. Parking passes, gate books, children's wristbands, pre-printed waivers, site tokens, etc., will be organized for easy

access. You will review everything, sign what you need to and be on your way! I expect that each person's registration to only take a few minutes, just like last year. No forms to fill-out there, it will be done ahead of time.

The attached Pre-Registration form is designed that you can print it out and follow the directions. I have a text-only version available by request. I can e-mail, mail or fax forms upon request.

Barony of Loch Salann Arts and Sciences Competition Criteria Rules for Entry

- The Baronial Arts & Sciences Competition is held annually on the third weekend of October
- 2. Anyone may enter. However, only residents of Loch Salann and its affiliated groups are eligible to hold the title of Baronial Champion of Arts & Sciences.
- 3. Each entrant is allowed a maximum of ten entries, with no more than eight in any single Grand Category.
- 4. No item may be entered which has previously been entered in a Loch Salann Baronial Arts & Sciences Competition. There is no time limit on the age of an entry, although an item that shows wear or is dirty may not place as well as one that looks new.
- Each entry must include documentation. There are no restrictions on the length of documentation. Research papers entered under Writing: Non-Fiction are their own documentation.
- Multiple Entries (one item entered in two or more categories) are allowed and will
 receive points for each category, provided the entry consists of two or more different art
 forms (i.e. a tunic with embroidery).
- 7. **Multiple Artists** (two or more individuals entering the same piece, but in different media) are allowed and will receive points for each category, provided each artist enters a different category (i.e. my woven textiles, her tunic, his embroidery).

Site Fee: \$3.00

Feast Fee: \$14.00 prepaid (children pay full fee for feast)

Feast is limited to 100 and prepayment is required. **Deadline is October 13, 2001**

Baroness' Champion Journey and A&S Champion Competition October 20, 2001 Salt Lake City, UT Barony of Loch Salann

Our Noble Baron and Beloved Baroness have sent a call throughout their land that a champion must be found to protect and defend the Baroness. Therefore, on the third Saturday in October, shall a grand tournament be held that our fair Tianna may view the best fighters in her land (heavy and rapier) and thereby choose that gentle best able to serve her in the coming year.

On this same day, shall a competition be held to showcase the talents of the artisans of the Barony. Many shall be the trinkets, baubles, and prizes awarded to those artisans who demonstrate their skills on this day. The populace is encouraged to bring trinkets to recognize those artisans who find favor in their eyes. From amongst the artisans, shall a new champion of Arts and Science be chosen to represent the Barony for the coming year. As befits such a day of celebration, there shall be merchants, games, classes, dancing and feasting to fill the day for one and all. Those wondrous purveyors of goods (merchants) are encouraged to contact the autocrat to reserve space. Merchant fee is a donation of one item to the goods auction. Tables and chairs will be provided. Those with a talent for teaching should likewise contact the Minister of Arts and Science that their talents might be shared with the many students eager to learn. Likewise doth the Minister seek judges fair that the work of the artisans may be both tabulated and encouraged. Please volunteer for this privilege.

Games there shall be for young and old including the famed signature game for the bounteous basket of goodies. A goods auction will also be held to raise funds for our fair barony. Donations to be auctioned to populace are encouraged and appreciated.

The day shall conclude with a sumptuous feast prepared by a Master Chef. Those attending do not need to bring feast gear but are encouraged to bring table décor and candles to add to the atmosphere. Dancing and celebrations with no set closing time will follow the feast.

Feast Menu:

Salad, Fennel Soup, Gilded Chicken, Green Peas, Barley Pilaf Assorted Breads and Rolls, Apple Juice and Water

- Group Entries (two or more artists entering the same piece) are allowed in the Performing Arts categories only, with each member of the group receiving the same score for the entry of the total points awarded.
- Performing Arts and Demonstration entries will be restricted to a maximum of ten minutes each.
- 10. Items made from kits are allowed, although an entry made from a kit will not place as well as one constructed from scratch because no score in the Creative section is permitted for a kit item. The use of a kit must be explicitly stated in the documentation or the entrant will be disqualified.
- 11. Works in Progress are allowed, although an item that is incomplete may not place as well as one that is finished. Documentation for a Work in Progress must include plans for finishing the item. Original scrolls lacking only the name and/or arms of the recipient are not counted as a Work in Progress. An item once entered as a Work in Progress may not be entered in another Loch Salann Baronial Competition, even after completion.

Registration

- 1. All entries must be pre-registered by October 10, 2001
- Each entry shall have the entrant's name displayed.
- Research papers, especially those longer than five pages, must be submitted to the Minister of Arts & Sciences for judging by September 19, 2001.
- 4. Absentee entries with documentation will be accepted provided the item has a guardian present, although an item without the artist to answer questions may not place as well as one accompanied by the entrant. Videotapes, but not audiotapes, will be accepted for absentee Performing Arts entries if advance notice of such submissions is given to the Minister of Arts and Sciences.
- To compete for Champion, the artist must enter at least five items in three Grand Categories.
- Should an entrant not wish to compete for Champion, the entrant must so indicate in writing on the registration sheet.
- Any entrant found to have falsely represented an entry will be disqualified from the entire Competition.

Judges and Scoring

- Judges will be selected by the Minister of Arts & Sciences. Judges may, should the need arise, be chosen from the populace in attendance who have expertise in the category.
- There shall be five judges for each category. All five judges shall judge together, if possible, each scoring on separate judging sheets. After judging, the high and low scores will be removed to give a more accurate score. Judges may judge more than one category.

- The judges may question the entrant for clarification. Only the entrants may answer questions or provide information about their own entries. Any individuals distracting the judges will be removed.
- 4. Artists are not permitted to judge their own entries. Any entrant who is competing for Champion is also not permitted to judge. Those entrants who have indicated in writing on their registration sheets that they do not wish to compete for Champion may judge those categories they have not entered, provided they have expertise in that category.
- Works shall be judged on their own merit and not necessarily compared to other works.
- Each entry will be judged on official judging sheets. Judges will sign their judging sheets.
- 7. All entries will be scored on a 0 to 50 point system as follows:

7a. **Documentation** criteria:

Judges will rate the quality and comprehensiveness of documentation. Minimal documentation consists of time, place, and style information. Although minimal documentation is required, extra points shall be awarded if the entrant discusses: Precedent, or rationale for original work or deviations from period norms; How the entry fits into period styles; Appropriateness of entry to a specified occasion, person, use, etc.; Acceptable source references. Clear, typed, well-organized and concise documentation is preferred. Avoid extraneous material.

Documentation scoring (0 to 5 points)

- No documentation.
- 1 Very inaccurate documentation, no explanation of choices. Descriptions of period practice with no mention of sources. Obviously un-period work.
- 2 Minimal information (time, place and style). Copies of pages from unknown books.
- 3 Minimal information plus visual references (photocopies, pictures, etc) to period examples OR minimal information plus discussion of period practice but no visual examples.
- 4 Minimal information plus visual references and discussion citing period examples.
- 5 Very complete examples and discussion including a well-developed commentary in all areas, use of critical sources, explanation or original research.

Documentation scoring for Performing Arts (0 to 5 points)

- No documentation.
- 1 Very inaccurate documentation.
- 2 Minimal information (time, place and style).

- 3 Minimal information plus some discussion of performance elements.
- 4 Minimal information plus copy of music or play, detail and sources, as well as a developed commentary and use of critical references.
- 5 Very complete information plus copy of music or play, including a well-developed commentary in all areas. Explanation of original research and/or experiments, and deviations or variations from period norms.

7b. Authenticity criteria:

Judges will rate how "period" the entry is in terms of style, function, appearance, combination of elements, etc. A piece will score lower if the entrant uses non-period elements or tools or materials. Judges should assume an entry is constructed with modern materials and tools unless otherwise stated in the documentation. Regardless of guidelines, a score of 10 goes to the piece that, in the judge's opinion, would have been accepted without question by a period audience.

Authenticity scoring (0 to 10 points)

- 0–1 Blatantly modern
- 2–3 Obvious mixture of elements from different cultures or periods.
- 4–5 Generally period, with some modern elements.
- 6–7 Overall period style; materials period or reasonable equivalents; some minor inconsistencies.
- 8–9 Overall period style; materials period or reasonable equivalents; no inconsistencies.
- 10 Special effort to achieve a completely period product by use of period design, techniques, materials.

Authenticity scoring for Performing Arts (0 to 10 points)

- 0-2 Blatantly modern in material choice or performance style.
- 3-4 Mixes performance elements and material of varying periods or styles.
- 5–6 Most performance elements are consistent with the selection and period.
- 7–8 All performance elements are appropriate to the material, performance environment and time period.
- 9–10 Special effort to enhance authenticity in addition to the above (i.e. period costumes, props, etc.).

7c. Complexity criteria:

Judges will rank the attempt, not the success of the entry. Judges assign ranking in a number of broad areas such as scope of endeavor, techniques required, and variety of elements combined. Entries that attempt very little or deal with styles in which simplicity was the norm will score lower here than entries that attempt a great deal. Likewise, if a simple-appearing end product depends upon extensive construction of tools and forms, it should be considered highly ambitious.

Complexity scoring (1 to 10 points)

Rank the ambition of the attempt, NOT the workmanship, from 1 to 10. Divide total by 6 for score.

Difficulty of materials used.

Difficulty of composition and/or preparation attempted.

Difficulty of design elements and/or construction attempted

Difficulty of techniques attempted

Variety of techniques attempted

Scope of undertaking (size of work relative to amount of detail)

Complexity scoring for Performing Arts (1 to 10 points)

Rank the ambition of the attempt, NOT the workmanship, from 1 to 10. Divide total by 5 for score. If an area is not appropriate, do not rank and divide by the number of areas judged.

Physical elements attempted (facial expressions, props, control, balance) Interpretive elements attempted (style, tempo, phrasing, dynamic contrast) Difficulty of techniques attempted (articulation, fluency, flexibility) Scope of endeavor (length, variety of elements, overall complexity) Difficulty of overall performance form

7d. Workmanship criteria:

Judges rank the success of the attempt. This includes how well the entry does what it was meant to do, how well its various elements work together, how skillfully the details are handled, etc.

Workmanship scoring (1 to 10 points)

Rank the success of the attempt from 1 to 10. Divide total by 4 for score.

Techniques (neatness, precision, choice and handling of materials) Form & Design (balance, aesthetics, motifs, proportion) Function (does it do what it should? Does it look as it should?) Mastery of period style and practice

Workmanship scoring for Performing Arts (1 to 10 points)

Rank the success of the attempt from 1 to 10. Divide total by 6 for score. If an area is not appropriate, do not rank and divide by the number of areas judged.

Mastery of period style and practice

Vocal elements: variety, inflection, projection, articulation, use of metrical values, impersonation

Physical elements: facial expression, gestures, movement, use of performance space, props

Interpretative elements: communication of meaning, emotional effects, interest level maintained

Integration of elements: overall timing, unity, transitions, creation of atmosphere Audience interaction and awareness

7e. Creative criteria:

Judges rank the extent of originality and innovation shown by the entrant, but the creativity shown must be in a period context (i.e. substitution of one logical element for another). Extra points should be awarded for appropriateness to a particular person, occasion, use, etc. Kits receive a score of 0 in this section.

Creative scoring (0 to 10 points)

- 1-2 Piece isn't logical in context of period
- 3–4 Logical combination or a few copied elements
- 5–6 Evidence of original work logical to period context in design or execution
- 7–8 Creative interpolation in combination or elements; much innovation logical to period context

John Lackland

(part four in a continuing genealogy of the Plantagenets)
By Fiona the Norseman's Daughter

Youngest son of Henry II and Eleanor of Aquitaine, John came to the throne in 1199 after more than a decade of scheming and conniving against his brother Richard. John had started creating problems for himself early on. Granted Lordship of Ireland in 1177, he went there in 1185 and offended both the native Irish and the Anglo-Irish nobility.

When Richard came to the throne, John was made Lord of Mortain, which became his usual title. He was granted £6,000 a year and married to Isabella, daughter and heiress of William, Earl of Gloucester in 1189. Richard went on Crusade; John promised in March of 1190 to stay out of England while he was gone but broke his oath when Richard designated his nephew Arthur as his heir in October. He opposed Richard's chancellor, William Longchamp, and when he heard Richard had been taken prisoner on his way home for the Crusades, allied with Philip Augustus of France to keep Richard imprisoned.

John was banished on Richard's return early in 1194 but later was reconciled with Richard and regained his lands and titles. Richard recognized him as his heir and he came to the throne on Richard's death in 1199.

John's marriage to Isabella of Gloucester had not gone well and was dissolved in 1199 on the ground of consanguinity—both of them were great-grandchildren of Henry I. There were no children born to their marriage. On 26 August 1200, he married Isabella of Angouleme, who had been betrothed to Hugh de Lusignan, provoking the Lusignans appealed to Philip II. A general war followed when John refused Philip's summons to appear before him. John won a victory at Mirabeau in August 1202, capturing Arthur of Britanny, who disappeared in custody. Normandy was lost in 1204; Anjou, Maine, and part of Poitou were lost by 1206. John was forced to take up residence in England. The English were to see more of John than they cared to.

Still determined to reverse his failure in France, John set out to raise funds to continue the fight, levying a number of new taxes. He refused to permit Stephen Langston to take up his position as Archbishop of Canterbury, causing Innocent III to place England under Interdict in 1208 and excommunicate John in 1209. Jon reconciled and submitted to Innocent in 1213 but by that tie he'd gained ore than £100,000 in church revenues. He managed to secure Innocent's support in his problems with is Barons later.

John took up his French campaign again in 1214 but achieved nothing but widespread discontent. Despite appeals from both sides to the Pope, civil war broke out. After London went over to the rebels, John was forced to negotiate and on 19 June 1215, he accepted the terms of the Magna Carta (Great Charter) at Runnymede. The Charter insured feudal rights and restated English law. Almost instantly, John repudiated it, appealing to Pope Innocent. At the request of the Barons, Prince Louis of France (later Louis VIII) invaded England. John fought vigorously but died suddenly, enabling a compromise to be reached. The crown passed to his young son, Henry.

Unlike his brother Richard, John left more than enough progeny. Though he and his first wife had no children, he and Isabella of Angouleme had five. He had six known mistresses and at least a dozen illegitimate children, though sources are contradictory as to which mistress had what children. John seemed willing to acknowledge his offspring. Many of these children married into the noble families of England. One child, Joan, married Llewellyn ap Iorwerth, Prince of Wales.

Creative scoring for Performing Arts (1 to 10 points)

Consider music, instruments or medium of performance, and physical aspects adding to the "periodness" of the performance. Note also instrument construction or adaptation, original composition or embellishment, setup, etc.

- 1–2 No original or adaptive elements, or incorrect adaptations
- 3–4 Some modification but no innovation
- 5–6 Attention to period styles with innovative use of elements
- 7–8 Creative interpolation in combination or elements; much innovation logical to period context
- 9–10 Original, innovative combination of all aspects of the performance, as might have done by a creative period artist. Special consideration such as personalization to an event, individual, or idea.

7f. Judge's Observation (0 to 5 points):

This is a totally subjective ranking of the entry's total effect (ooh-aahs!). This is the only place where a judge's personality and private opinions should be allowed to influence scoring.

The judges shall provide constructive commentary explanation on the judging sheets for each score. Should a dispute arise between an entrant and a judge, the Baron, the Baroness, and the Minister of Arts & Sciences shall review the case, and can in extreme cases order the item rejudged.

Tabulation and Awards

- The five judging sheets for each entry will be tabulated with the removal of the high and low scores and the entry shall be awarded its combined total points. Should any of the judging sheets be missing at the time of tabulation, the Minister of Arts & Sciences may have the item re-judged by another qualified judge so that there are five complete judging sheets for each entry.
- All entries will be placed according to total point score, with the highest score winning the category.
- 3. The total point scores are as follows:

Masterpiece 135–150 Exceptional 115–124 Superior 125–134 Notable 95–114

The judges may give out more than one award in any of these levels. A category may yield more than one Masterpiece, or perhaps no awards at all.

- 4. The Champion shall be determined by the greatest number of points totaled from the five highest-scoring entries of a qualified candidate for the Championship. These five highestscoring entries are allowed to be in a single Grand Category.
- 5. Should there be a tie for the title of Champion, the Champion will be determined by second-highest score among the entrants' highest-scoring five entries. Should this fail to break the tie, it will be determined by the third-highest; then fourth; then fifth until the tie is broken.

- 6. The second-place winner shall be titled the Loch Salann Arts & Sciences Reserve Champion.
- Entrants winning the highest single point score within each Grand Category will be declared Lord or Lady of that Grand Category, and will hold that position until another category winner is declared.
- 8. The winner of the Novice Category will be declared the Loch Salann Arts & Sciences Novice Champion.
- The winner of the Children's Category will be declared the Loch Salann Arts & Sciences Youth Champion.
- The populace attending the Competition shall choose a Populace Champion by the placing of counters.
- Any disputes will be reviewed by the Coronet and the Minister of Arts & Sciences. All decisions made by this group will be final.

Champion

- 1. The winner of the Competition shall hold the title of Champion of the Arts & Sciences of the Barony of Loch Salann until the next Competition is held.
- The Champion has the right to attend the Coronet at court and to wear the Arts & Sciences Champion's Medallion and cloak throughout the year of service.
- 3. The Champion shall be responsible for furthering the Arts & Sciences within the Barony, and for those duties assigned to the Champion by the Coronet.
- The Champion shall serve the Coronet by autocratting the Competition event at the end of their year of service.
- The Champion is responsible for notifying the Minister of Arts & Sciences of any duties assigned by the Coronet to the Champion, as well as the progress and completion of those Champion's duties.
- The Populace Champion, Reserve Champion, Novice Champion, Youth Champion and the Lords or Ladies of Grand Categories shall, at the pleasure of the Coronet, be made part of the Royal Court, process or stand as needed, and will aid the Champion in promoting the Arts & Sciences.
- 7. The Minister of Arts & Sciences and/or the Autocrat will be responsible for commissioning original scrolls for each of the Champions, and copy scrolls for Masterpiece, Superior, Exceptional, and Notable entries in each category and the Lord or Lady of each Grand Category. Original scrolls for a Competition may be entered in that Competition at the artist's discretion and need not be counted as Works in Progress. The Minister and/or the Autocrat may provide any additional scrolls or prizes as they choose.
- The Minister of Arts & Sciences shall be responsible for publishing the names of the Champion, Reserve Champion, Masterpieces, and Lords and Ladies of the Grand Categories, and any other names of entrants and their achievements in the Quill.

The evening of August 7, 2001, was a lovely setting for the members of the Baronial Cook's Guild to meet at the home of Lady Constance De La Rose to prepare and partake of wonderful foods as a preview to this years Solstice feast. These recipes came from the cookbook "Pleyn Delit Volume Two".

Under the direction of Lady Constance, Mistresses Casamira and Margaret, along with His Lordship James set about to prepare Hirchones(Sausage Hedgehogs) of pork and game, Sawse Camelyne(Cameline Sauce) for the meat, Fresh Raw Vegetables(Carrots, Celery, and Cauliflower), Crème Bastard(White Custard Sauce)with Strawberries, and Baked Custard.

We were joined by Master Edward, Lord Draco, and M'Lord Rafael just in time to eat these wonderful foods. The meal was lively with puns, jokes, and movie reviews. We also shared our sadness, at the fact that Lordship Vogg was not able to join us, due to mundane matters. After eating our fill (and then some) we chose the following recipes to share with you. Enjoy!

Creme Bastard (White Custard Sauce)

2 egg whites, slightly beaten 1 cup plus 2 tsps. milk 2 Tbls. Honey Pinch salt

2 tsps. sugar

Put the egg whites in a sauce pan with 1 cup of the milk and stir over medium heat as it comes to a boil. Let it simmer for about 5 minutes, stirring constantly. Then add the honey and the salt. After simmering for another minute or two, remove from heat and strain or blend in a blender adding remaining milk and sugar. *Pour into a pitcher or serving dish and chill. It will thicken as it chills. This is good with washed, hulled, slightly sweetened strawberries.

Baked Custard

This dessert calls for the same ingredients and directions as the above recipe, with the following additions. Find the * in the above recipe. Instead for pouring into a pitcher, pour into an oven safe serving dish. That dish is then placed in another pan, containing at least 2 inches of water. This is now placed in a preheated 350 degree oven and left to bake for 20 to 25 minutes or until golden brown .

Demonstration Projects - This category is limited to 10 minutes.

Enameling - Basse-taille, champlevé, cloisonné, grisaille, Limoges, plique à jour, en resille.

Equestrian, Tack and Trappings - Tack, saddles, bits, bridles, barding, special riding garb, etc. **Equestrian, Performance** - Demonstration of technique: period dressage and warhorse movements.

Falconry - Demonstration of technique; also accoutrements such as hoods, jesses, gloves, lures, etc.

Fief Holding - Animal husbandry, hunting/fishing equipment, gardening, horticulture, SCA coverups, shelters, etc.

Fine Arts - Drawing, painting, portraiture, sculpture, etc. Subtleties are specifically excluded from Fine Arts.

Glass - Lampwork, beads, blown vessels, stained glass, etc.

Heraldic Display - Heraldic displays in any media. This includes parades — which are limited to 10 minutes.

Horn, Bone, Ivory & Amber, Non-Jewelry - Carved, fabricated, inlaid, etc.

Hounds - Demonstration of technique: coursing, hunting, etc; also accoutrements such as barding, lures, etc.

Jewelry - Soldered, non-soldered, strung jewelry, lapidary, etc.

Knitting

Lace - Bobbin, needle, etc.

Leatherwork, Non-Armor - Shaped, tooled, etc.

Manuscript Arts - Calligraphy, illumination, cartography, etc.

Metalwork, Decorative Non-Jewelry - Casting, fabrication, etching, forging, raised work, chasing, repoussé, etc.

Metalwork, Functional Non-Jewelry - Same categories as Decorative. Knives and swords are entered under Functional Metalwork.

Musical Instruments - Brass, keyboard, percussion, string, woodwind, etc.

Needlework - Appliqué, beading, couching, counted work, cutwork, goldwork, needlepoint, needleweaving, pulled thread, stumpwork, surface embroidery, etc.

Performing Arts: Solo - This category is limited to 10 minutes. Country dance, court dance, ethnic dance, instrumental music, monologues, plays, reading, vocal music, etc.

Performing Arts: Group - Same categories as Solo, also limited to 10 minutes.

Printing Sciences - Bookmaking, papermaking, printing, etc.

Textile Arts: Construction - Braiding, carding, dyeing, resist dyeing, fabric painting, felting, spinning, sprang, etc.

Textile Arts: Application - Basketry, brocade, card weaving, damask, inkle, plain weave, satin, tapestry, twill, etc.

Tools - Hand tools, production tools, scientific instruments, pens and brushes, etc.

Toys & Games - In any media.

Weapons - Bowyery, fletching, mechanical war machines, SCA weapons, etc. Knives and swords (if metal) are entered under Functional Metalwork.

Woodwork, Decorative - Carving, joinery, inlay, marguetry, turned, etc.

Woodwork, Functional - Same categories as Decorative. Includes furniture.

Working Models/Historical Technology - Windmills, sawmills, looms, architecture, furnaces, kilns, forges, etc.

Writing: Fiction - Plays, poetry, tales, etc. Persona stories are allowed, but strongly discouraged. **Writing:** Non-Fiction - Documentation, historical research, instructional articles, music, research projects, song (lyrics), etc.

Novice

Open to first-time entrants in any of the Grand Categories; however, first-time entrants are not required to enter as Novice. Any artist who enters a Novice category is ineligible to compete for Loch Salann Baronial Arts & Sciences Champion, and competes for Loch Salann Baronial Novice Champion only.

Children's

Open to children 15 years old or younger in the same Grand Categories. Any child who enters a Children's category is ineligible to compete for Loch Salann Baronial Arts & Sciences Champion, and competes for Loch Salann Baronial Youth Champion only. However, there are no age restrictions on Loch Salann Baronial Arts & Sciences Champion, and any child who feels comfortable competing in the Baronial Competition may do so.

Other

This includes that which does not fit elsewhere. The Lord or Lady of this category is given a title descriptive of his or her art and does not become Lord or Lady of Other; rather, Lady of War Stratagems, for example.

Grand Categories in Bold

Sub-categories are guidelines and are listed on the registration and judging sheets for the judges' clarification only.

Alchemy - Both cooked and non-cooked: soap, candles, pot-pourri, perfume, etc. Also includes inks. paints and pigments.

Armor - Parade, field, ring mail, chain mail, flexible armor, leather, gambesons, etc. or SCA-only. **Brewing, Vintning and Cordials** - Beer, ale, lager, stout, liqueurs, mead, wine, sparkling wine, etc.

Ceramics - Coiled, flat construction, modeled, molded, wheel-thrown, etc. Commercial molds are considered kits.

Cooking - Bread, cheese, main dish, non-alcoholic drinks, side dish, sweet dish/desserts, etc. Subtleties are specifically confined to the cooking category.

Costuming, Court - Pre-1000 AD, 1000–1400 AD, 1400–1500 AD, 1500–1600 AD, and non-European.

Costuming, Tourney - Same categories as Court.

Costume Accessories - Hats, shoes, gloves, purses, pouches, pomanders, masks, fans, etc. and detachable items for use on more than one garment such as hoods, collars, cuffs, stomachers, beaded ornamentation, etc. but not sleeves.
